Construction: It has multi bend construction with an interlocking design and full-length overlapping doors and sides. It should have the SS Mazak handle. The Almirah should have a 3-way locking mechanism. The two doors shall have Min. 3 hinges mounted on each door. Should have one locker on the right-hand side with 2 hanging provisions with central partition. The bottom shelf should have an inbuilt flap storage system.

Doors: The doors have one handle and lever locking mechanism with Six lever Mazak

Zinc Plated Lock.

Powder coating: All steel components undergo an eight-tank anti rust treatment and oven Baked epoxy polyester powder coating with 50-60-micron dry film thickness. It will sustain the Salt Spray test to withstand more than 1000 hours as per IS-101, Pencil scratch hardness greater than 2H, Adhesion as per DIN 53152 Standards.

Configuration: It has 3 full shelves and 1 half shelf made of 0.9 mm thick CRCA steel sheet with stiffener. The steel sheet will be oven baked epoxy polyester powder coated with 40-50 dry film thickness.

Colour: Silver grey powder coated or Olive green or Prince grey.

Weight of complete constructed Almirah: 68-70 kg. Superseding the gauge.

A maximum of ± 0.5mm deviation is allowed on the dimensions of all the items.

2. <u>In place of clause 8, read</u>:

"90% Payment of order value will be made against delivery of material as per Purchase order & acceptance by IIIT Raichur within 30 Days on execution of complete delivery and submission of Invoice. Balance 10% will be released after submission of performance bank guarantee equal to 03% order value for period of warranty plus 60 days and installation report."

3. In place of clause 9, read:

"The material supplied shall carry Five year of comprehensive warranty from the date of installation and acceptance of the items by IIIT Raichur. Warranty shall include free maintenance of the whole item supplied, including free replacement of parts. The defects, if any, during the guarantee/warranty period are to be rectified free of charge by arranging free replacement wherever necessary. This includes cost, freight, local taxes or any other charges which should be borne by the Bidder"

4. In place of clause 10, read:

"The quotation must be submitted by 24th July 2023 at 3:00 P.M."

Additionally, the following terms and conditions have been included:

- 1. **Delivery Date:** 21st August 2023 at IIIT Raichur Hostel/Any Location in IIIT Raichur
- 2. The bidder must have supplied similar hostel furniture items to at least 3 Centrally Funded Technical Institutes (CFTIs) in the last 5 years. In this regard, performance certificates or work completion certificates should be enclosed. A complete list, along with the contact details of the customers, must be provided. Feedback from the users will be sought by the IIIT Raichur if felt necessary, and these feedbacks will form an integral part of the Technical Evaluation.
- 3. The bidder should have valid certifications like Integrated Management System [IMS] for quality, environment, energy, etc., such as ISO 9001, 14001, AIOTA & valid copy of certificates should be enclosed.
- 4. Vendor must be a BIFMA Member company, and the same will be verified from the BIFMA website, https://www.bifma.org/page/MembersList.
- 5. **Price:** The price quoted shall be considered firm, and no price escalation will be permitted. The price criteria should be F.O.R., IIIT Raichur. Govt. Levies if any, shall be paid at actual rates applicable on the date of delivery. Rates should be quoted accordingly, giving the basic price and taxes, if any.
- 6. **Performance Bank Guarantee**: The successful bidder is required to submit the Bank Guarantee (03% of order value) valid for warranty period of 5 years + 60 Days Installation: Bidder shall be responsible for installation and for after sales service during the warranty and thereafter. Installation is to be arranged by the supplier at no cost. No subcontracting will be allowed for installation. Inspection: The inspection of the items supplied will be done by our committee in the presence of the firm's representative. In case of receipt of the material in short supply or damaged condition the supplier will have to arrange the supplies/replacement of goods free of cost.
- 7. **Commencement of Warranty Period**: The warranty period of the items shall commence from the date of its satisfactory installation & commissioning at the project site in IIIT Raichur. The warranty period and validity of Performance Guarantee shall be extended for the period of delay in satisfactory installation and delay in warranty services.
- 8. **After Sales Service:** The Supplier should arrange for regular visit as and when requested by IIITR.
- 9. Indemnity: The vendor shall indemnify, protect, and save IIIT Raichur against all claims,

losses, costs, damages, expenses, action suits and other proceeding, resulting from infringement of any law pertaining to patent, trademarks, copyrights etc. or such other statutory infringements in respect of all the Hostel Furniture's as per this tender supplied by him

- 10. **Risk Purchase Clause:** In event of failure of supply of the item within the stipulated delivery schedule by the bidder, IIIT Raichur has all the right to purchase the items from the other source on the total risk of the supplier under risk purchase clause.
- 11. Force Majeure: IIIT Raichur may consider relaxing the penalty and delivery requirements, as specified in this document, if and to the extent that, the delay in performance or other failure to perform its obligations under the contract is the result of a Force Majeure. Force Majeure is defined as an event of effect that cannot reasonably be anticipated such as acts of God (like earthquakes, floods, storms etc.), acts of states / state agencies, the direct and indirect consequences of wars (declared or undeclared), hostilities, national emergencies, civil commotion and strikes at successful Bidder's premises or any other act beyond control of the bidder.

If a Force Majeure situation arises, the Supplier shall promptly notify the IIIT Raichur in writing of such conditions and the cause thereof. Unless otherwise directed by the IIIT Raichur in writing, the Supplier shall continue to perform its obligations under the contract as far as is reasonably practical and shall seek all reasonable alternative means for performance not prevented by the Force Majeure event.

- 12. **Sub-contracting:** No subcontracting is allowed with regard to installation, commissioning, after sales service. This is the sole responsibility of the Bidder or his authorized agents.
- 13. **Unloading of Furniture at IIIT Raichur**: The bidder has to arrange the unloading of the Furniture items at IIIT Raichur Hostel/Any Location in IIIT Raichur.
- 14. **Security Deposit**: Within ten (10) days of the award of contract, the vendor/ their Agent shall furnish a Security Deposit amounting to 3% of the purchase order value in the form of Demand Draft/Bank Guarantee (from scheduled Bank only) favoring the Indian Institute of Information Technology Raichur payable at Raichur. The Security Deposit should be valid for a period of 60 days beyond warranty period as the same will be extended as Performance Bank Guarantee.

Bank Guarantee wherever mentioned in this document may be read as "Bank Guarantee from any National Bank /Scheduled Bank".

- 15. Interpretation of the clauses in the Tender Document / Contract Document: In case of any ambiguity / dispute in the interpretation of any of the clauses in this Tender Document, the Competent Authority of IIITR interpretation of the clauses shall be final and binding on all parties.
- 16. All other terms and conditions of the quotation remain the same.
- 17. The last date of quotation submission is extended up to 24th July 2023 till 3:00 P.M.
